WMTel Representative presented agreement to council. Motion by Hollman to approve letting them put equipment on the water tower with annual rent of \$1,200 and 5 free connections, 2nd by Meyer. Approved.

Motion by Park to add Reliable 1 Heating to the Agenda, 2nd by Bruns. Approved.

Kirk from Reliable 1 Heating and Cooling explained what was wrong with 1 of the 3 furnaces at the community center/city hall and suggested replacement. Presented 4 different options for the council to decide upon. Motion by Bruns to purchase Daikin 2 Stage variable speed furnace for \$5,007.63. 2nd by Ketchum. Approved.

Mort's Payment 14 - Motion by Ketchum to approve, 2nd by Bruns. 3 Ayes, 2 Nayes. Approved.

Change Order #23 - Motion by Park to approve, 2nd by Bruns. Approved.

Change Order #23 - (extending contract to April 2019 to finish landscaping, etc.) Motion by Bruns to approve, 2nd by Hollman. Approved.

Spare Parts - Discussion, including using the fire department to haul backwash water.

Motion to approve Treasurer's report by Bruns, second by Hollman. Community Center/Library Improvements - Clerk will seek out estimates for floor cleaning/painting. Other small items such as a ladder and a shovel were discussed.

Rowan Improvement Foundation gave update on fundraising for buttresses at Rowan Events Center, once funding is in place, city will have to sign off on contracts since they own the property.

Maintenance - Park - Will need to purchase more softener salt and furnace filters.

Sewer Progress - No further discussion

Building Permits - None.
