# **ORDINANCE NO. 20-1**

# AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF ROWAN, IOWA, BY AMENDING PROVISIONS PERTAINING TO TRAFFIC AND VEHICLES.

BE IT ENACTED by the City Council of the City of Rowan, Iowa:

SECTION 1. Chapter 60, Section 60.02(3); Chapter 69, Section 69.09(2); Chapter 70, Section 70.03; Chapter 75, Section 75.04(1)(8) of the Code of Ordinances of the City of Rowan, Iowa, 2018 are hereby Modified:

### 60.02 DEFINITIONS.

3. "Peace officer" means every officer authorized to direct or regulate traffic or to make arrests for violations of traffic regulations or to enforce City Code.

## 69.09 TRUCK PARKING LIMITED.

- 2. All Night. No such vehicle shall be left unattended or parked upon any of the following designated streets or alleys for a period of time longer than (1) hour, between the hours of two o'clock (2:00) a.m. and six o'clock (6:00) a.m. of any day.
  - a. Main Street on both sides from Elizabeth Avenue to Ballou Street.

70.03 PARKING VIOLATIONS: ALTERNATE. Admitted violations of parking restrictions imposed by this Code of Ordinances may be charged upon a simple notice of a fine of fifty dollars (\$50.00) payable at the office of the City Clerk. An additional five dollars (\$5.00) will be charged if violation is not paid within thirty days from the date of violation. Failure to pay the simple notice of a fine shall be grounds for the filing of a complaint in District Court. Failure to pay parking fines owed by you can be grounds for refusing to renew your motor vehicle's registration. (Code of Iowa, Sec. 321.236)

# 75.04 PLACES OF OPERATION

- 1. Streets. ATV's and snowmobiles shall be operated only upon the following streets which have been designated as snowmobile routes:
  - a. Bingham Avenue
  - b. Patton Street

- c. Ballou Street
- d. Pritchett Street
- e. Elizabeth Avenue between Patton Street and Main Street
- f. Main Street between Bingham Avenue and Elizabeth Avenue
- 8. Private Property. ATV's and snowmobiles shall not be operated upon private property unless given express permission by the owner of the property.

# SECTION 2. Severability

- 1. All Ordinances or parts of ordinances in conflict herewith are hereby repealed.
- 2. The invalidity of any section, clause, sentence, or provision of this ordinance shall not affect the validity of any other part of this ordinance which can be given effect without such invalid part or parts.

### SECTION 3. Ordinance in Force

1. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
