Motion by Bruns to waive the 3rd reading of the Ordinance, 2nd by Hollman. Motion carries. Motion by Bruns to approve Ordinance Amendment 21-03 Council Compensation, 2nd by Groom. Approved unanimously. Motion by Hollman to waive the 3rd reading of the Ordinance, 2nd by Groom. Motion carries.

Snow bids – Motion by Hollman to approve the bid submitted by Mountain Movers, 2^{nd} by Park. Approved.

Halloween – Was decided to have Trunk-or-Treat on Main Street on October 31st from 4-6 PM. Soup Supper and Tree Lighting – Will be December 4th from 5-7 PM.

Fire Dept Raffle – Discussed changes to be added to tickets, motion by Groom to approve, 2^{nd} by Park. Approved.

710 Duffy - Motion by Bruns to approve the contract as written by the City attorney and execute it, 2^{nd} by Groom. Approved.

Trees – Hollman didn't see any acceptable trees at the nursery.

Building permits – None
