## **DEFINITIONS**

- Maximum Contaminant Level (MCL) The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) -- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ppb -- parts per billion.
- ppm -- parts per million.
- pCi/L picocuries per liter

- ND -- Not detected
- RAA Running Annual Average
- Treatment Technique (TT) A required process intended to reduce the level of a contaminant in drinking water.
- Action Level (AL) The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a
  water system must follow.
- Maximum Residual Disinfectant Level Goal (MRDLG) The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Maximum Residual Disinfectant Level (MRDL) The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

# GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. #### **COLIFORM ASSESSMENT**

During the past year we were required to conduct 1 Level 2 assessment to determine the cause of bacteria in our distribution system. Corrective actions have been, or will be taken to address these issues. If a health concern is present, you will be notified.

A Level 2 Assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system on multiple occasions.

In March 2021 we had a Lead Consumer Notice (Pb/Cu) violation for Lead & Copper Rule.

In 2021 we received a public notice rule violation for failure to provide information to our customers regarding the Revised Total Coliform Rule (RTCR) MCL violation.

## SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the limestone and dolomite of the Mississippian-Devonian aquifer. The Mississippian-Devonian aquifer was determined to be slightly susceptible to contamination because the characteristics of the aquifer and overlying materials provide moderate protection from contaminants at the land surface. The Mississippian-Devonian well will be slightly susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application.
