

Resolution No. 2024-07

WHEREAS, the City Council of the City of Rowan, Iowa, subject to the 2024 Code of Ordinances of Rowan; Chapter 17; 17.02(5) “The council shall authorize, by resolution, the number, duties, term of office and compensation of employees or officers not otherwise provided for by State law or the Code of Ordinances”,

AND WHEREAS, Effective October 1, 2024 the Water Superintendent is retiring and an Affidavit Operator has been contracted,

AND WHEREAS, employees of the City of Rowan are paid monthly upon approval of claims at the regular City Council meeting on the first Monday of each month,

AND WHEREAS, the City Clerk is hereby authorized to issue compensation less legally required, or authorized, deductions from the amounts set out below,

AND WHEREAS, payroll intervals, overtime provisions, and other related payroll personnel procedures shall be conducted in the manners prescribed by the Fair Labor Standards Act,

AND WHEREAS, elected officials are paid pursuant to 2024 Code of Ordinances of Rowan; Chapters 15(15.04), 16(16.04) and 17(17.06),

THEREFORE, BE IT RESOLVED, that the City Council of Rowan, Iowa hereby authorizes the following salaries and wages for appointed officers and employees for the City of Rowan effective October 1, 2024 and for the remainder of Calendar Year 2024.
